Safety

Vehicle Safety

IAW CAPR 77-1, para 2-2h In areas where a vehicle operator cannot see clearly behind the vehicle, the use of a spotter is required when backing to eliminate the chance of a mishap. The exception to this is when another individual is not available. In this event the vehicle should be positioned, if possible, in such a way that backing is not required.

Safety Surveys

We are currently in the 1 Oct - 31 Jan window for completing the annual unit safety surveys. Please keep in mind that this is a survey and not a compliance activity. This year's survey questions go outside of the typical compliance questions found in past surveys. Therefore we fully expect answers to not always be blanket "yes" and will probably involve actions over time to better educate and train members in areas that will increase our safe operations above on beyond regulatory minimums. (Ref CAPR 62-1)

Personal Protective Equipment (Vests)

ANSI Class 2 or 3 vests and apparel are now mandatory. Prior to 1 Oct 2012, ANSI approved vests were required if performing CAP duty within the rightof-way of Federal-aid highways but our members could wear non-approved vests for other CAP activities. Now ALL the apparel worn when required for CAP must meet the ANSI Class 2 or 3 standard. The standard ensures minimum amount and location of enhanced visibility and reflective material and in many cases is better than some of the older (cheaper) vests used. Vests and apparel meeting the ANSI standards are readily available from several local sources because they are mandated by law for anyone working around most roads/highways (police, surveyors, highway workers, reporters, etc). CAP members can confirm their vest meets the Class 2 or 3 standard by checking the label. (Ref CAPR 6-1).

Compliance Item

IAW CAPR 100-1, para 6-14c. "Systems used to interconnect repeaters and remote base stations must support encryption at all times. Effective immediately, any new system of this type must automatically retransmit original encrypted signals without unsecure intermediate decrypting and re-encrypting. In other words, signals that were originally encrypted may not be passed through unsecured networks unless preserved in their original encrypted form. Existing systems must be brought into compliance by 31 December 2012." If you can not comply with these policies it is imperative that you request a waiver immediately. Use the commpermissions @capnhq.gov address to get your request into consideration. If you require a waiver, please act quickly. Waivers will be granted on a case-bycase basis only and you will need proof of a granted waiver if asked by an inspector.

Compliance Item

IAW CAPR 100-1, para 8-4e. "Dual Mode Required. All CAP repeaters, including tactical repeaters, must be capable and programmed to respond to either analog or digital P-25 signals, meaning that regardless of whether the radio is set on an analog or digital channel, it will receive signals transmitted in either mode. Unless specifically authorized in writing by the NHQ/DOK, no narrowband VHF-FM repeater may be operated with access limited to only one mode. Analog-only narrowband repeaters are not authorized after 31 December 2012." If you can not comply with these policies it is imperative that you request a waiver immediately. Use the commpermissions @capnhq.gov address to get your request into consideration. If you require a waiver, please act quickly. Waivers will be granted on a case-by-case basis only and you will need proof of a granted waiver if asked by an inspector.

Chaplain Corps Staff College 2012

Six chaplains and 1 character Development Instructor attended the college. The College Instructor provided the students with fourteen hours of CISM training in the areas of Individual Crisis Intervention and Peer Support. Chaplain Lt Col Ken Van Loon, one of the Deputy Chiefs represented National Chaplain Ellis at the college and provided an update on the CAP Chaplain Corps. The college concluded with a banquet in which Certificates of Completion were presented by Chaplains Packer and Van Loon.

CAP SUNDAY 12/1 - 12/2

"In 1972, the CAP National Board designated the first Sunday in December as CAP Sunday. Soon after that, the Saturday before was added to the celebration for those whose day of worship is Saturday. The week-end commemorates the fact that CAP was chartered by the U.S. Congress on December 1, 1941. CAP Sunday/Sabbath gives CAP Chaplains an opportunity to acquaint their churches with their ministry as CAP Chaplains. Sometimes units may choose to support their chaplains by all worshipping in the same place, and in uniform. Other units, encourage members to attend the church or synagogue of their church in uniform. This is an excellent opportunity to take the message of aerospace to non-CAP members. For chaplains, it is also an excellent opening for telling their religious bodies about the importance of moral leadership in CAP." Each member of the Chaplain Corps, chaplain and CDI alike, as well as all CAP members, are encouraged to proudly wear their uniform to the worship service they attend on either 12/1 or 12/2 – be it the service dress, the corporate uniform or the blazer combo. It is also noteworthy that Gill Robb Wilson, one of the founders of CAP, was an ordained Presbyterian Minister and is even called CAP's first "Chaplain" (CAP News, June 2000).
